

**SCHEDULING OF MATTERS IN THE CRIMINAL DIVISION BETWEEN  
MARCH 16<sup>th</sup> and APRIL 30, 2020**

**Courtroom C10-Arraignment and Presentments** will operate on a normal schedule, with the exception of citation cases, which will be continued.

**Courtroom 115- Preliminary Hearings:** All preliminary hearings will proceed as scheduled, absent a motion to continue being filed.

**Status and Diversion Hearings- Traffic, Misdemeanor, Felony 2 and Felony 1 Calendars**  
Detained Defendants: All status hearings for detained defendants will proceed as scheduled, absent a motion to continue being filed.

Non-Detained Defendants: All status hearings for non-detained defendants shall be continued for seven weeks to the date set forth in the attached schedule, unless either party requests an earlier date.

**Misdemeanor Non-Jury Trials:**

Detained Defendants: All nonjury trials set on the misdemeanor and traffic calendars for detained defendants scheduled between March 16<sup>th</sup> and March 27 will be converted to a status hearing on the original trial date for purposes of selecting a new trial date. All nonjury trials set after March 27<sup>th</sup> will proceed as scheduled, absent a motion to continue being filed or further extension of time as ordered by the Chief Judge.

Non-Detained Defendants: All non-detained trials shall be converted to status hearings and continued for seven weeks to the date set forth in the attached schedule, unless either party requests that the case receive priority status by filing a motion with the Presiding Judge or her designee at least one week prior to the originally scheduled trial date.

**Jury Trials**

All trials for which a jury has already been selected will proceed as scheduled and jurors must report to the jury room as previously instructed by the trial judge.

Detained Defendants: All detained jury trials scheduled between March 16 and March 27 shall be converted to a status hearing on the original trial date for purpose of selecting a new trial date. No jurors will be summoned during this time. All detained jury trials set after March 27<sup>th</sup> will proceed as scheduled, absent a motion to continue filed by the parties or further extension of time as ordered by the Chief Judge.

Non-Detained Defendants: All other jury trials set shall be converted to status hearings and continued for seven weeks to the date set forth in the attached schedule, unless either party requests that the case receive priority status by filing a motion with the Presiding Judge or her designee at least one week prior to the originally scheduled trial date.

**Pretrial and Probation Show Cause Hearings** will proceed as scheduled.

**Bench Warrants:** Bench warrants will not be issued on the originally scheduled citation arraignment, status or trial date; all bench warrant rights will be reserved. However, a bench warrant may issue if an individual fails to appear for the continued date.

**Appearances:** Counsel, Pretrial and CSOSA may appear telephonically, with the permission of the court, for all hearings with the exception of matters in C10 and preliminary hearings.
